

Signing up for the payment plan

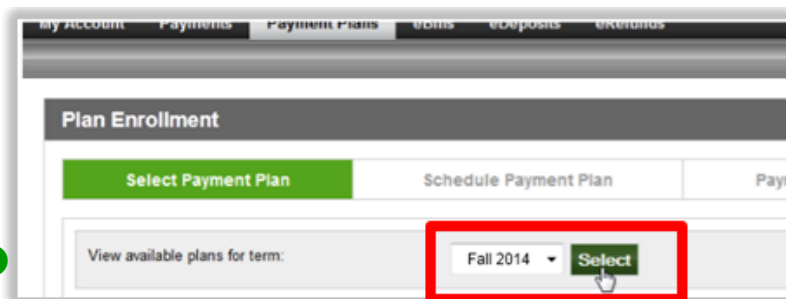
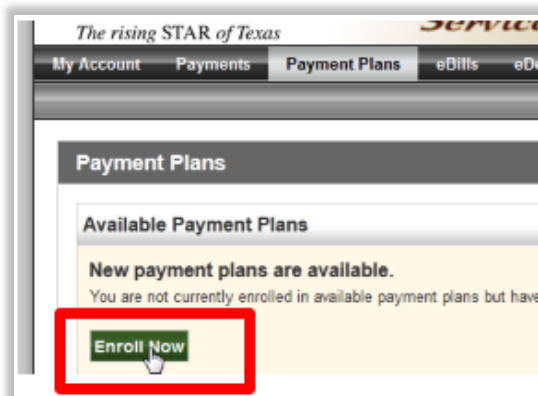
Sign up for the Payment Plan on the SBS Touchnet payment site by clicking on the Students or Parents link:

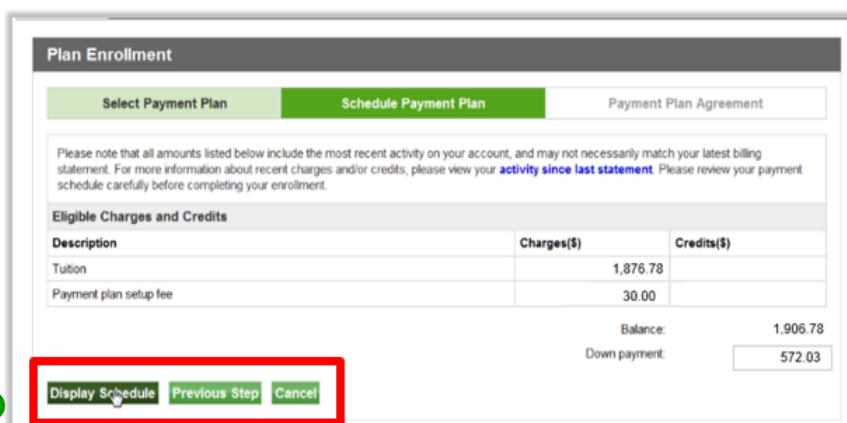
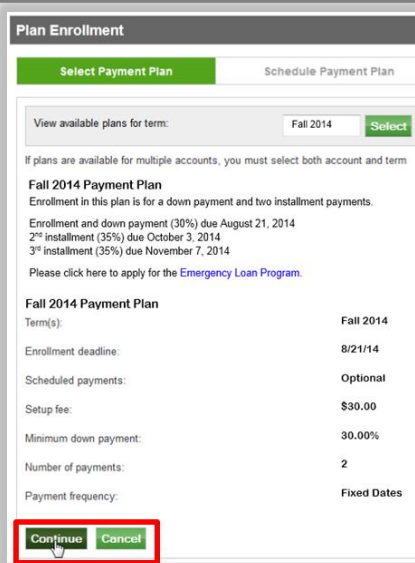
Log in with your NET ID and password and click on the **Payment Plans** tab:

At the **Payment Plan** screen, do the following:

1. Click **Enroll Now**.
2. Select the correct semester from the drop down menu.



3. Review terms of the plan and click **Continue** to schedule the plan.
4. Click **Display Schedule** to review down payment* and installment amounts.



**Financial Aid and/or credits can be used towards your down payment. However, you must wait until after disbursement on 8/15/14 to enroll in the plan.*

- If you are in agreement, check "I agree" and click **Continue**.
- Select Payment Method and follow the prompts to make the down payment.
