

Seven accounting faculty members participated in Grant Thornton's Annual Audit Summit Training in Houston held at the Rice Hotel in early January. The day-long training program included a lease accounting refresher with an update on the new lease accounting regulations, a discussion of issues related to ASC 606



and auditing revenue, and an overview of data analytics and innovation with a focus on new audit software and techniques. Beta Alpha Psi (BAP) kicked off its first meeting of the spring 2018 semester on February 8. Before getting into the requirements and other specifics of BAP, **President Nick Olteo** gave a 15-minute presentation about risk management. Every semester the Student Organization Council (SOC) requires the president of each organization to present its members with the information contained in a PowerPoint provided by SOC. On Tuesday, February 13, NABA hosted **Anna-Marie Parker**, the campus recruiter for BKD, to discuss elevator speech. Anna-Marie presented an informational PowerPoint that discussed what elevator speech is, what employers look for in elevator speech, and the structure of elevator speech. NABA members learned that professionalism is very important in elevator speech and that they needed to end the speech with a call to action, such as asking for a business card or a way to follow up about an open position. The presentation stressed that elevator speech is about selling yourself, so recruiters can see how a student will fit into a particular position. When giving this 30-45 second speech, students need to remember:

"BE PRECISE, BE PERSUASIVE, BE PROFESSIONAL."

BAP Hosts PwC

On Thursday, February 15, BAP hosted PwC at the second chapter meeting in McCoy. PwC is a Big 4 public accounting firm with 100's of offices around the world that hold over 200,000 employees.

At this meeting, **Rachel Von Gonten** spoke about PwC's "Be Well, Work Well" initiative. The initiative focuses on maximizing employee health and happiness through the four major energy channels: physical, emotional, mental, and spiritual. Employees are asked to take an energy audit and change their negative habits into positive ones. These habits can be found at habitbank.pwc.com, and BAP members were asked to pick one habit from each of the four energies to develop in the future. Some examples of habits are:


Physical: taking a walk around the office

BUSINESS LEADERSHIP WEEK

Business Leadership Week (BLW) is an annual event that supports the Texas State University common experience. The common experience is a year-long, university-wide event that promotes student engagement and encourages conversation on a theme by bringing in speakers and exhibits related to the theme. The common experience theme for 2017/2018 is “Searching for Justice”. In an effort to better tie the common experience theme with the study of business, the Business Leadership Week committee, in consultation with **Dr. Denise Smart**, settled on the McCoy College of Business BLW 2018 theme of “Integrity in Business”. The Department of Accounting was responsible for two key BLW events.

First, the Accounting Club hosted a panel of four industry professionals (top right). The four panelist (**Sarah Barbatto**, Supervisor, Income Tax Energy Transfer Partners; **Sue Clark**, Controller, Horizon Structural Systems Inc.; **Dusty Whitaker**, Sr. Capital Asset Accountant, Summit Hotel Properties; and **Robert Zearfoss**, CFO and Executive VP, **Randolph Brooks** Federal Credit Union) discussed their unique career paths after obtaining a university degree and answered student questions (p. 20).

The second event was a distinguished lecturer event. **Dr. Cecily Raiborn** invited **Mr. Billy Petty** CFE to come speak as a distinguish lecturer (middle). Mr. Petty currently works as a forensics specialist with Heyman & Associates PLLC. Approximately 130 students were on hand to listen to Mr. Petty who provided insights that he has gained over a 25+ year career in financial crime investigations. Mr. Petty closed his lecture by providing practical, cost-effective controls that management can implement to reduce the likelihood of becoming a victim of fraud.

These events provide students with an opportunity to learn more about what it is like working as a business professional and the options available to accounting majors. Accounting majors have numerous career path options and it is not easy choosing which path is best, so the Department of Accounting encourages all student to attend events hosted by student organizations (Accounting Club, BAP, NABA, etc.) and BLW to learn more about these career opportunities.

ROBERT ZEARFOSS, CFO, *Randolph Brooks Federal Credit Union, one of the largest credit unions in the United States. Based in Texas, they serve more than 500,000 members and have more than \$6 billion in assets*

Before starting the panel, Accounting Club's previous president, **Tulsi Bhakta**, discussed the IMA Conference that some officers had attended last semester. **Mr. Bruce Howard** then led the panel session by asking structured questions, including what the best and worst parts of their day were.




On Thursday, March 1, Beta Alpha Psi hosted Ernst & Young (EY) during their third meeting of the semester. EY is another Big 4 accounting firms that has 100's of offices around the world and over 200,000 employees. They are also a platinum sponsor, host the EY Etiquette Dinner every fall, and heavily recruit at our university. BAP is always happy to host them because they do so much for accounting students.

At this meeting, **Callie Jones** gave a presentation about EY's new interview process. Callie explained the process, best practices for using the technology, and gave great advice when it came to typical interview questions. In the past, EY did the standard in-person interviews on campus and then an in-person interview in their office.

Now, EY has adopted an online interview. In this interview, students answer pre-recorded questions and then have three attempts and three minutes to answer them. The previous attempts are deleted. Students move on to in-person interviews on campus if they pass the online interview. If they get the offer, students go on an EY office visit to learn more about the firm while participating in special games and activities.

BAP Hosts Grant Thornton

On Thursday, March 22, Beta Alpha Psi hosted Grant Thornton during their 4th meeting of the semester. Grant Thornton is the 6th largest accounting firm in the United States. It has 59 offices in 30 states with 550 partners and over 7,000 employees.

Katie Beatty, a senior manager at the Houston office, gave a presentation about emotional intelligence. She spoke about the 5 pillars of emotional intelligence which are self-awareness, self-regulation, motivation, empathy, and social skills. She stated that emotional intelligence is two times more important than IQ and technical skills.

After her presentation she had the students go through two separate exercises. The first exercise was over conflict. Members were split into groups of 3-4 people and they had to come up with six different synonyms to describe conflict. Next, they had to partner up with another group and trim their list of six down to four. Finally, students had to group up with the entire class and narrow the list down to just two

synonyms. There was some debate during this activity, but ultimately the more vocal and dominate group won out on choosing the final two synonyms.

The second exercise was a solo exercise. Students wrote down significant experiences in their lives that shaped them into the people they are today. Three students then shared what they wrote who also happened to be the three most vocal students during the previous exercise.

These exercises created interesting discussions between BAP members and allowed them to learn more about each other.

"This was one of the more interesting meetings due to the exercises, and I actually learned quite a bit about the students in our org from this one," said Nick Oloteo, President of BAP.

BAP looks forward to hosting Grant Thornton again in the future.

Accounting Club member **Alexander Cannon** (left) teamed up with **Matthew DisSalvo** of St. Edward's University (right) to serve as panelists for a presentation at the American Accounting Association Southwest (AAA-SW) regional meeting held in Albuquerque in March of this year. Alex and Matt were two of only three undergrads who gave presentations at the conference. The topic of the panel was "Claims Denied from Natural Disasters: Should There be an Accounting?" Their focus was on the need for financial statement note disclosure of claims not paid for property insurance losses. Both students have family and friends who suffered serious losses during Hurricanes Katrina and Harvey. Their presentation was attended by accounting faculty from a five-state area, and they received numerous compliments for their work. The panel was moderated by **Dr. Carolyn Conn**, Clinical Assistant Professor here at Texas State.



IMA STUDENT CASE COMPETITION FINALISTS

Five accounting students have earned one of only four team finalist positions in the Student Case Competition sponsored by the Institute of Management Accountants (IMA).

The team is comprised of three students from our undergraduate Cost Accounting classes and two from the graduate Cost class: **Elisa Amkreutz, Joey Courville, Peyton Dilts, Julia Lara, and Greg Russell.**

To qualify as finalists, the team prepared quan-

titative analyses of accounting data and evaluated qualitative factors associated with a strategic planning decision for a hypothetical company. They then wrote and produced a 15-minute video of their recommendations.

On June 17, the team will do a live presentation before a panel of judges at the IMA Annual Conference and Expo. The team says they intend to "bring home the gold"!

VITA 2018

The VITA (Volunteer Income Tax Assistance) clinic provides free tax return preparation for taxpayers in the greater San Marcos community. The clinic ran from February 12—March 28 and was a great opportunity for Texas State accounting student volunteers to learn more about the field of tax accounting via organizing, preparing, and filing tax returns for their clients. The clinic provided a tremendous free service to Texas State students, personnel, and the residents of San Marcos.

This year, volunteers assisted with 60 returns and filed 53 of those returns. The greeters kept the clinic organized and answered client questions, while the student preparers received real life experience by preparing tax returns that held Schedule C business income, Schedule D investment income, and Schedule E royalty income. Clients ranged from full-time students to families with children and from restaurant servers to Hollywood script writers. Overall, the clinic helped generate over \$52,000 in refunds for the clients, including a \$5,000+ refund for one family.

The clinic's success this year would not have been possible without a team of exceptional volunteers. In total, over 20 individuals volunteered at the clinic this year. Our top preparer was **Tazeen Khandker** who was honored with the Most Returns Completed and Most Evenings Worked awards at the Accounting Excellence Awards Banquet. **Melanie Schuchert** and **Katelyn Disney** served as our "Senior Managers" this year at the clinic. The two graduate assistants attended every clinic, where they set up and tore down the clinic, prepared returns, and acted as low-level reviewers. Melanie also



obtained site coordinator certification. **Kelly Laxson** handled all of the logistics and ensured the clinic ran smoothly. **Dr. Chris Proschko** served as the site coordinator and faculty sponsor.

VITA will be offered again next year, and we are hoping to help even more individuals with their taxes. Thank you to all of the volunteers who gave their time to help make the clinic a success. We hope to see you again next spring.




