F-1 students are required by the Department of Homeland Security to maintain the terms and conditions of their nonimmigrant status. Failure to maintain status will result in the termination of a student’s SEVIS record and require immediate departure from the US. F-1 students are required to pursue a "full course of study" every fall and spring semester; full-time in summer is only required when a student is admitted to begin in the summer term. A “full course of study” is considered full-time enrollment, which is **9 credit hours for graduate students and 12 credit hours for undergraduates. Dropping or registering below full-time enrollment without prior approval from International Student and Scholar Services (ISSS) is considered a violation of status.**

An academic RCL may be authorized only once per degree level and requires enrollment in at least six credit hours.

This form must be signed by the student’s academic or faculty advisor and submitted to ISSS prior to the first day of classes or prior to dropping a course that results in less than full-time enrollment.
